Background of the RE-CENTRE Project

The project "cRoss-sEctoral Cluster approach for higher CompEtitiveNess through digiTal, gReen transition and rEsilience" - RE-CENTRE - Traditional manufacturing and technological sectors (IT&Green) SMEs teaming up, acquiring know-how and competences for future challenges has received funding from the European Union's SMP-COSME-2021-CLUSTER — Joint Cluster Initiatives (EUROCLUSTERS) for Europe's recovery programme.

The RE-CENTRE project, through the systemic cooperation of 2 clusters related to traditional sectors of furniture, furnishing, interiors, living environments (DID Italy, AMBIT Spain), 1 related to the Green sector (GSC Bulgaria) and 1 to the IT sector (Cluj IT Romania), develops around 5 main action areas, interpreted as 5 seeds for supporting SMEs in rooting on the market towards higher resilience and business stability.

Scope and schedule: FSTP for internationalization

RE-CENTRE Eurocluster is organizing a one time open call for the Financial Support to Third Parties: GO INTERNATIONAL. The main objective of this RE-CENTRE open call is to financially support eligible SMEs to approach one or two of the targeted countries – Mexico and Chile – via online B2B meetings and sign cooperation agreements envisioning international trade, investment and partnering with identified entities in at least one of the 2 markets.

Financial support to third parties-FSTP- Scheme Description

The Call is defined, implemented and managed in steps on a dedicated form: https://ec.europa.eu/eusurvey/runner/2024 Re-Centre Internationalization OpenCall

- 1) submission of applications;
- 2) evaluation process: eligibility & requirements check done by the ReCentre Consortium
- 3) the applications that comply to the call requirements and eligibility criteria, will be selected for funding on a first-come-first-served basis, until the budget of the open call is exhausted, but not later than the open call end date.

Each interested SME can participate in maximum one proposal for this type of FSTP in the RE-CENTRE Eurocluster.

The SME applicant cannot apply for and/or receive funding outside of RE-CENTRE for a similar project that could lead to a potential double funding of the same action.

The above-mentioned statements regarding the double-funding must be confirmed by the SME applicant in the self declaration included in the application form.







Eligibility conditions and application procedure

Applications for the GO International FSTP are eligible if all of the following conditions are met:

- 1) To be funded, the applicant must be an SME and declare their SME status (e.g. staff headcount below 250, turnover below or equal to 50M€ or balance sheet total below or equal to 43M€) in accordance with the SME definition of the European Union. Please check the Commission recommendation for SME definition in the following link: EU recommendation 2003/361. If unsure, please check and carry out a quick SME self-assessment via as part of the application via this link:
- 2) The SME must be registered in one of the EU or non-EU countries eligible for the support from the Single Market Programme, applicants must check eligibility of their country prior to applying https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/smp/guidance/list-3rd-country-participation_smp_en.pdf
- 3) The SME must be active in at least one of the 3 targeted sectors: 1) the traditional furniture and living sector, 2) the IT sector, and 3) the green/circular economy sector
- 4) Each SME can participate in maximum one proposal under the present FSTP call
- 5) The application must be written in English, using the provided template.
- 6) The application must be submitted through the online submission tool available at https://ec.europa.eu/eusurvey/runner/2024 Re-Centre Internationalization OpenCall before the deadline of the open call.
- 7) The SME must indicate its main objective of internationalization related to the targeted countries (Mexico or Chile) within the scope of the RE-CENTRE open call (chose one of the options below):
 - explore and understand opportunities to open a new market, in which to expand and promote SME's products and services by collaborating with local entry points and networking operators (b2b meeting and MOU signing with any of the following type of entities: clusters, business associations, commerce chambers, other entities active in business development areas)
 - o consolidate international trade: identify new potential clients and / or providers ((b2b meeting and MOU signing with at least one potential client or provider)
 - invest in new markets expand the business for increased competitivity (b2b meeting and MOU signing with potential partners for business expansion)
 - other (please indicate)

Important: the applicant will upload the filled and signed Declaration of Honor (Annex 1) as a proof of the compliance with the eliqibility criteria.

Where you can apply

After submission, the applicant will receive an automatic acknowledgement / receipt of proposal submission with date and time.

When you can apply

The RE-Centre Open Call Go International is launched on 12th of July 2024.

Applications must be submitted prior to the open call deadline at 17:00 CET on 12th of September 2024.

This is an ongoing open call to allocate at least 3 vouchers, with applications evaluated and funded on a first come - first basis. The RE-CENTRE consortium retains the option to close the open call ahead of schedule if the budget is meanwhile depleted.

Eligible applicants will be contacted directly with a formal confirmation. Subsequent applications will be included in a reserve list and will be contacted if previously selected applicants fail to sign the Sub-Grant Agreement.

Evaluation and selection of proposals

An assessment procedure will be followed safeguarding the principles of transparency and equal treatment. The evaluation process starts with the assessment of the eligibility of the applicant, according to the criteria above (see chapter: Eligibility conditions). Only those applications fulfilling all eligibility criteria, completing all mandatory fields in the application form and providing all required documents will be considered eligible. The applications are evaluated and funded on a "first come first served" basis.

In order to comply with the conditions set out in the Eurocluster call for proposals, to ensure that a minimum of 10 % of the selected SMEs are registered in EU countries other than the RE-CENTRE consortium countries, that is other than Bulgaria, Italy, Romania and Spain, at least 1 voucher is reserved for SMEs compliant with this requirement.

The assessment period takes max. 2 (two) weeks starting from submission. The applicant will receive an email about the outcome of the assessment and then the results will be published.

Redress Procedure

In case an applicant consortium considers that their application was rejected due to a mistake, they can send (via email at info@csm.toscana.it, in English) an appeal for redress within 3 calendar days after the receipt of the e-mail with the evaluation outcome. The appeal must include:

- Name of application and contact details
- Subject of the redress appeal
- Clear and detailed argumentation related to the application outcome, including evidence

The RE-CENTRE consortium will review the appeals in maximum seven calendar days from its reception. In case more time is needed, the RE-CENTRE consortium will inform the applicant via email.

Payment conditions

In maximum 60 days after the receipt of the selection letter, the selected SME will provide to the RE-CENTRE consortium the following documents:







- 1. Present at least one MOU signed with an entity active in at least one of the targeted countries, Mexico or Chile, as a result of their internationalization efforts. The MOU entity can be an SME, a company who can become a potential client, cluster or business association, commerce chamber, or other entities active in business development areas. A template for the MOU is available in Annex 4.
- 2. Present a short descriptive report of the internationalisation action (one page)
- 3. Present the filled and signed SME Financial information RE-CENTRE Beneficiary (Annex 5)
- 4. Present the filled and signed SME GDPR Agreement (Annex 6)

Important: in order for the action to be eligible for funding, it must take place after the submission of the application under this call and within 60 days from the receipt of the selection result.

All payments between the Eurocluster RE-CENTRE consortium and the selected SMEs will be made in Euro (€) in the SMEs bank account, in maximum 30 days after the receipt of the above-mentioned documents (points 1, 2, 3, 4). Expenses documents are not required.

Submission of an application does not constitute an entitlement for funding.

The recipients of FSTP from Re-Centre ("Beneficiaries") must ensure that the European Commission, the European Anti-fraud Office (OLAF) and the Court of Auditors (ECA) can exercise their powers of control on documents, information, even if stored on electronic media, or on the final recipient's premises.

Beneficiaries' main obligations include:

- The SME must acknowledge the EU support in their communication activities related to the project, as described in the Annex 3
- They must keep records and other supporting documentation for at least five years and make them available upon request or in the context of checks, reviews, audits or investigations.
- If there are on-going checks, reviews, audits, investigations, litigation or other pursuits of claims under the grant agreement (including the extension of funding), the SME must keep the records and other supporting documentation until the end of these procedures.
- The SME must keep the original documents. Digital and digitalised documents are considered originals if they are authorised by the applicable national law. Non-original documents may be accepted if they offer a comparable level of assurance.

Confidentiality and data protection

GDPR compliance: The General Data Protection Regulation (2016/679/EU) guarantee that the processing of data is carried out in compliance with the fundamental rights and freedoms, as well as the dignity of the data subject with particular reference to confidentiality, personal identity and the right to data protection.
